

4.2. DISBURSEMENTS AND DISBURSEMENTS FEE

4.2.1. DISBURSEMENTS

1. Definition

Disbursements are amounts collected at destination for the provision of services which are incurred at origin which are incidental to the air carriage of the consignment. Such services will be limited to the transportation, handling and documentation performed prior to the air carriage from the point of departure indicated on the AWB. Disbursements will be collected by the last carrier and will accrue to the issuing carrier for payment to an agent or to another carrier. Disbursements must be entered as due agent or due carrier in the "Other Charges" box (23) of the AWB

2. Restrictions

- Disbursement apply only if "Charges Collect" shipments are accepted at destination (see sections 7.2.).
- Disbursements do not apply for traffic to Algeria.

4.2.2. Disbursement Amount

1. General

Any disbursement amount (s) shall not be in any case in excess of the "Total weight charge" shown in box 24A or 24B (as applicable) of the AWB.

2. Restrictions

- When the "Total weight charge" is less than USD 100.00 (or equivalent) disbursements of up to USD 100.00 (or equivalent) (except in Hong Kong (SAR) up to USD 300.00) are permitted.
- For traffic to Zambia the maximum amount (s) of any disbursement may not be more than USD 100.00 (or equivalent) .

4.2.3. DISBURSEMENT FEE

1. Definition

For the collection of disbursement amount (s) a disbursement fee will be assessed. Such disbursement fee shall also apply to all the other "collect charges" shown in box 23 of the AWB. Such fee shall be inserted as due carrier in box 23 of the AWB. It shall be collected by the last carrier and shall accred to the issuing carrier.

2. Disbursement fee calculation

Such fee shall correspond to 10% but not less than USD20.00 (or equivalent) (except in Brunei Darussalam 10%, but not less than BND 50.00 and except in Singapore 8%, but not less than USD 17.00) of the amounts shown in box of the AWB.

3. Restrictions

- Applicable to OS: From Austria a fee of EUR 13.08 applies for disbursement amounts less than EUR 81.39.
- Applicable to LH: From Germany a fee of EUR 12.00 applies for disbursement amounts less than EUR 73.00 and of EUR 30.00 for amount from EUR 73.00 up to EUR 300.00.
- Applicable to OA: From Greece a fee of EUR 9.39 applies for disbursement amounts less than EUR 41.09.
- Applicable to AZ: From Italy a fee of EUR 10.00 applies for disbursement amounts less than EUR 50.00.
- Applicable to TP: From Portugal a fee of EUR 7.98 applies for disbursement amounts less than EUR 49.88.

4. Conversion USD into local currency

In countries listed in the table below, the amounts shown shall be used instead of the USD 100.00 and USD 20.00 indicated in paragraphs 4.2.2. and 4.2.3.
