1.2.2. DEFINITIONS OF AREAS

IATA AREA 1

All of the North and South America Continent and the adjacent islands, Greenland, Bermuda, The West Indies and the islands of the Caribbean Sea, the Hawaiian Islands (Including Midway and Palmyra).

IATA AREA 1 - SUB AREAS

Caribbean sub-area

- a. between USA(excluding Puerto Rico and the US Virgin Islands) and the Bahamas, Bermuda,the Caribbean Islands, Guyana, Suriname, French Guiana;
- b. between Canada/mexico and the bahamas, Bermuda, the Caribberan Islands(including Puerto Rico and the US Virgin islands), Guyana, Suriname, French Guiana;
- c. i) within the area composed of the Bahamas, Bermuda, the Caribbean islands(Including Puerto Ricp and the US Virgin Islands)
 - ii) between area under c-i) above on the one hand and Guyana, Suriname and French Guiana on the other hand.

Mexico sub-Area

Between Canada/USA (excluding Puerto Rico and the US Virsin Islands) and Mexico.

Long haul sub-area

- a. Between Canada, Mexico, USA on the one hand and Central America and South America on the other;
- b. Between Bahamas, Bermuda, the Caribbean Islands,
 Guyana, Suriname, French Guiana on the one hand and Central
 and South America on the other;
- c. Between Central America and South America
- d. Within Central America

For the purpose of difinition of the "Curebbean" and "Long haul" areas the following is defined:

Caribbean Islands:

Anguilla, Antigua and Barbuda, Aruba, Barbados, Bonaire, British Virgin Islands, Cayman Islands, Cuba, Dominica, Dominican Republic, Grenada, Guadeloupe (including St. Barthelemy and Northern St. Martin), Haiti, Jamaica, Martinique, Montserrat, Netherlands Antilles, St Kitts-Nevis, St. Lucia, St. Vincent and the Grenadines, Tobago and Trinidad, Turks and Caicos Islands.

Central America:

Belize, Costa Rica, El Salvador, Guatemala, Honduras, Nicaragua. South America:

Argentina, Bolivia, Brazil, Chile, Colombia, Ecuador, Panama, Paraguay, Peru, Uruguay, Venezuela.

IATA AREA 2

All of Europe (including the European part of Russia) and the adjacent islands, Iceland, the Azores, all of Africa and the adjacent islands, Ascension Island, that part of Asia lying west of and including Iran (Islamic Rep. Of).

IATA AREA 2 - SUB AREAS

Within Europe sub-area:

Albania, Algeria, Andorra, Armenia, Austria, Azerbaijan, Azores, Belarus, Belgium, Bosnia and Herzegovina, Bulgaria, Canary Islands, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Georgia, Germany, Gibraltar, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, macedonia (the former Yugoslav Rep. Of), Madeira, Malta, Moldova, Monaco, Morocco, Netherlands, Norway, Poland, Portugal, Romania, Russia (in Europe), San Marino, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, Tunisia, Turkey (in Europe and Asia), Ukraine, United Kingdom, Yugoslavia.

Within Middle East sub-area:

Bahrain, Egypt, Iran (Islamic Rep. Of), Iraq, Israel, Jordan, Kwait, Lebanon, Oman, Palestinian Territory (Occupied), Qatar, Saudi Arabia, Sudan, Syria, United Arab Emirates (comprised of Abu Dhabi, Ajman, Dubai, Fujairah, Ras al Khaimah, Sharjah and Umm al Qaiwain), Yemen.

Within Africa sub-area:

Central Africa, Eastern Africa, Indian Ocean Islands, Libyan Arab Jamahiriya, Southern Africa and Western Africa.

Central Africa:

Malawi, Zambia and Zimbabwe.

Eastern Africa:

Burundi, Djibouti, Eritrea, Ethiopia, Kenya, Rwanda, Somalia, Tanzania and Uganda.

Indian Ocean Islands

Comoros, Madagascar, Mauritius, Mayotte, Reunion Island and Seychelles Islands.

Southern Africa:

Botswana, Lesotho, Mozambique, South Africa, Namibia and Swaziland.

Western Africa:

Angola, Benin, Burkina Faso, Cameroon, Cape Verde, Central Africa Republic, Chad, Congo (Brazzaville), Congo (Kinshasa), Cote d'Ioire, Equatorial Guinea, Gabon, Gambia, Ghana, Guinea, Guinea Bissau, Liberia, Mali, Mauritania, Niger, Nigeria, Sao Tome and Principe, Senegal, Sierra Leone and Togo.

IATA AREA 3

All of Asia and adjacent islands exceptthat portion included in IATA Area2 all of the East indies, Australia, New Zealand and the adjacent islands, the islands of the Pacific Ocean, except those included in IATA Area 1.

IATA AREA 3 - SUB AREAS

South Asian Subcontinent sub-area

Afghanistan, Bangladesh, Bhutan, India (including Andaman islands), Maldives, Nepal, Pakistan, Sri lanka.

South East Asia sub-area:

Brunei Darussalam, Cambodia, China (People's Rep. of), Guam, Hong Hong(SAR), Indonesia, Kezakstan, Kyrgyzstan, Lao(People's Dem. Rep.), Malaysia, Marshall Islands, Micronesia (includes Caroline Islands except Palau Islands Group), Mongolia, Myanmar, Northern Mariana Islands (includes Mariana islands except Guam), Palau, Philippines, Russian Federation (East of the Urals), Singapore, Taiwan, Tajikistan, Thailand, Turkmenistan, Uzbekistan, Vietnum.

South West Pacific sub-area:

American Samoa, Australia, Cook islands, Fiji islands, French Polynesia, Kiribati, Nauru, New Caledonia, New Zealand (including Loyalty Islands), Niue, papua New Guinea, Samoa, Solomon Islands, Tonga, Tuvalu, Vanuatu, Wallis & Futuna islands.

Japan/Korea sub-area, that is within the area composed of: Japan and Korea.
